COMMUNITY SPOTLIGHTS

CASCADIA CONSERVATION DISTRICT **Chelan County, WA**

Cascadia Conservation District (CD) is dedicated to encouraging the wise stewardship of all-natural resources - with partnerships at the center of their work. Working closely with researchers, fire districts, land management agencies, community-based organizations, Firewise USA® sites, and local municipalities, Cascadia CD identifies and implements community fire adaptation projects with residents that contribute to large-scale landscape restoration and public safety across the county. cascadiacd.org

FIRE ADAPTED METHOW VALLEY (FAMV) **Okanogan County, WA**

In 2021, FAMV piloted an equitable wildfire mitigation program for the elderly, low-income, and other vulnerable community members. They collaborated with agencies, nonprofits, volunteers, and contractors to identify best practices and workable solutions for client selection, risk assessments, vegetation removal, funding, and client contributions to address each individual's unique, personal circumstances and reduce wildfire risk.

NETWORK HIGHLIGHTS

POLICY LEARNING GROUP

It is difficult to imagine a future where this nation can live with wildfire without also imagining a fundamental shift in wildfire policy and governance. Tackling the conversations about wildfire policy and governance, however, can be daunting. Over the course of six months in 2021, 70 wildfire practitioners from 17 states across the nation joined the national Fire Adapted Communities Learning Network (FAC Net) and WAFAC to learn more about how to engage with agencies, elected officials, staff, and more in order to be more effective in their own communities.

At a state level, WAFAC wildfire practitioners connected their work to the state legislative and policy process. Participants met monthly to deepen their individual skills, hear from those working in the policy sphere, and learn more about effective strategies to engage with policymakers and staff.

The skills, knowledge, and partnerships developed in the policy learning group led to

- An **empowered group** of community members who testified at the state legislature hearings on Bill 1168 Forest Health and Reducing Wildfire Risk.
- **New partnerships** with the Washington Environmental Council and Sustainable Northwest and **strengthened relationships** with the Washington Prescribed Fire Council and the Latino Community Fund who work actively on landscape and community wildfire policy issues.
- **Better understanding** of how to engage with local and State-level decisionmakers, what information they need, and how to connect on-the-ground work to State-level strategic plans and initiatives.
- Strategic connections with decision-makers at the local level who are now supporting and advocating for on-the-ground implementation of community fire adaptation projects.
