

## CLIMATE AND THE GROWTH MANAGEMENT ACT: THE RELATIONSHIP TO COMMUNITIES AT RISK TO WILDFIRE

Climate change exacerbates the factors that create perfect fire conditions. Increased temperatures, changes in rain and snow patterns, shifting vegetation types, forest and vegetation management decisions, and the distribution of homes, structures, and people in our natural environment are heightening the potential for wildfire.

Community wildfire practitioners, land managers, residents, and policy-makers are using and considering tools to help minimize the risk of wildfire to communities, one being land use planning. Land use planning can help communities determine where to allow development, what types of building materials will help keep people safe, and what infrastructure is needed to safely respond when disasters strike.

HB 1099 Improving the state's climate response through updates to the state's comprehensive planning framework is working to address a myriad of natural resources issues through the Washington State Growth Management Act (RCW 36.70a).

The Washington Environmental Council and the Washington Fire Adapted Communities Learning Network hosted a virtual event (<u>recording</u>) to introduce Washington residents and stakeholders to HB 1099 and share how the relationship to communities at risk to wildfire and shared the following resources with event participants.
